TriLitCo LLC ("Company") is committed to maintaining robust privacy protections for its users. This Privacy Policy ("Policy") explains how we collect, use, safeguard, and share the information you disclose when using our website ("Site") and services ("Services").

For purposes of this Policy:

- "Site" refers to the Company's web pages at @TriLitCo.com.

I. Information We Collect

Cookies and Tracking Technologies:

We use the collected information for these purposes:

- 3. Marketing: Subject to your consent, sending you promotional messages, offers, or updates about TriLitCo.

TriLitCo LLC ("Company") is committed to maintaining robust privacy protections for its users. This Privacy Policy ("Privacy Policy" or "Policy") is designed to help you understand how we collect, use, safeguard, and share the information you provide to us or disclose by using or interacting with our website ("Site") or service(s) ("Service" or "Services").

For purposes of this Policy, "Site" refers either to the Company's webpages at @TriLitCo.com. By "Service" or "Services", we mean the Company's services accessed via the Site, including but not limited to provision, operation, and availability of the Site and any websites, features, applications, widgets, and other services provided or made available by Company that point to this Policy. Technologies such as cookies, web beacons, web storage, and unique advertising identifiers may be used to automatically collect certain technical information when you use our Site or Services. Such usage is intended to administer and analyze users' use of the Site and Services, improve functionality, and deliver personalized content and advertisements.

In addition to the information collected automatically, we may also collect information that you provide us. This includes information provided during account registration, use of the Site, access to the Services, onboarding and client intake processes, and engagement with third-party or participating vendors or providers. By registering an account or providing information during the client-intake process, you authorize us to collect, store, use, and share this information as reasonably necessary to serve rational purposes.

II. Information Sharing
